LAC Rules and Regulations (Please read carefully and initial each section)

1. I (We) agree to abide by all of the Longwood Athletic Club rules and regulations that management has established and implemented. Any member who fails to abide by these rules and regulations may have their membership revoked per the discretion of Longwood Athletic Club. Members shall forfeit all or any portion of their paid annual or monthly dues if their membership has been revoked by Longwood Athletic Club for failure to comply with the rules and regulations.
2. I (We) hereby agree to waive any claim and rights that I (we) may otherwise hold employees, owners, officers or agents of Longwood Athletic Club, Inc liable for any injuries that may occur as a result of these activities. Longwood Athletic Club will make no evaluations or recommendations whether I (we) am (are) physically fit for any exercise activity. I (we) are (am) also aware and advised to consult with my (our) physician as to the limits of physical stress and activities I (we) may indulge in at Longwood Athletic Club.
3. My failure to attend and utilize Longwood Athletic Club's facility does not relieve me of my obligation, regardless of the circumstances, to pay the court rent or guest fees.
4. Parents, guardians, chaperones, guests, renters or members who bring a minor (age 17 and under) onto Longwood Athletic Club's property, shall be responsible for their safety and conduct. Children age 16 and under must be accompanied by an adult at all times, unless participating in a club supervised program.
5. Longwood Athletic Club reserves the right to close the facility for private functions and for maintenance and/or repairs to any and all amenities.
6. All court rent and guest fees are subject to change at the discretion of LAC management.

Club House Rules:

1. All court rent or guest fees must be paid for in full before entering the Longwood Athletic Club facility. If payment is not received Longwood Athletic Club can deny access to the facility.
2. For the safety and security, please do not leave bags of any kind in the lobby.
3. Proper etiquette must be displayed at all times while on Longwood Athletic Club premises.
4. Please be courteous, the Member Lounge is for all Longwood Athletic Club Members and their guests, dry clothes and person are required. Please pick up after yourself. If you make a mess, please clean it up immediately and/or notify the front desk.
5. Shirt and shoes are required at all times inside the club house. Proper attire is required for the appropriate athletic activity.
6. Please be courteous and refrain from using interior furniture while wearing wet or soiled clothing. Tiny-Two-Steps are provided by each entrance to clean shoes prior to entering facility
7. Tampering with club radios, TV's or club equipment is forbidden and may be cause for membership revocation.
8. There is no soliciting on Longwood Athletic Club property.

Fitness Center & Sauna Use Policy:

1. Be safety conscious at all times.
2. Athletic shoes are required. No open toed shoes or sandals. Wear appropriate clothing.
3. Please wipe down equipment after use.
4. Rack all weights and dumbbells after use. Don't leave weights on machines.
5. No "open mouth" containers. All drinks must be in "spill proof" containers.
6. Please limit time on cardiovascular equipment. **Be respectful of others.**
7. Children 16 and under must be supervised at all times, while in the fitness center.
8. Sauna is off limits to all children under the age of 18. Please notify front desk prior to use of sauna.

Tennis and Sports Courts Use Policy:

1. Please rinse shoes before entering hard courts and sports courts, and after playing on clay courts.
2. No black sole shoes. Proper athletic shoes must be worn on all courts.
3. Members may book courts 3 days in advance. Play may not exceed 1 _ hours.
4. Players must check in at the front desk to receive court assignments.
5. Member/non-members taking lessons must check-in and pay at the front desk prior to lesson.
6. Athletic equipment must not be taken for use without permission.

Playground Equipment Use Policy:

1. Adult supervision is **required** for all children playing on playground equipment.
2. Equipment is for children ages 2 – 8 and must be used for its intended purpose.
3. Equipment is for members and their guests only. Equipment is not for public use.
4. **NO FOOD or DRINK** on or near playground equipment.

Swimming Pool Use Policy:

1. **There is No lifeguard on duty. Swim at your own risk facility**
2. Untrained children must wear a swim diaper.
3. No running on decks. No diving. No glass containers. No horseplay of any kind.
4. In case of thunder or lightening the pool will be closed until reopened by management.
5. No food or drinks in pool. Food and drinks may be consumed only at tables.
6. Pool is open during daylight hours.
7. Pool hours may be designated for specific usage.
8. No open abrasions, lacerations, or cuts. **Be safety conscious at all times.**
